He holds 8,000 equity shares, representing 0.01% of the company's equity, and has confirmed that he no longer has any control over the company's management or affairs.</p> <p>Following this request, the Board of Directors approved the reclassification during their meeting on April 3, 2024. Subsequently, the company obtained shareholder approval for this reclassification through an ordinary resolution passed via a postal ballot on June 14, 2024.</p> <p>To complete the process, the company has filed an application with BSE Limited under Regulation 31A of the SEBI (LODR) Regulations, 2015, and is currently awaiting their response.</p>
